

AP300 Rental Agreement Terms

Rate: The monthly rental rate for the AP300 Analyzer System is \$2400 per month.

Payment Instructions: Payment by PO or by credit card is accepted.

Billing: The rental contract begins when the AP300 Analyzer System is received at your location. This is referred to as your contract "anniversary date". At the commencement of the rental contract, the first month's rent is due within 30 days. Each month, on the anniversary date, the previous month's rental fee of \$2400 is due. This payment system will continue until your company or a representative of your company notifies us by telephone or by email with receipt of acceptance by Ridley Engineering. This notification must be received at least seven days prior to the next anniversary date. Otherwise, an additional month's rental will be charged.

Technical Support: During the rental period, you will have access to daily technical support by telephone or email from our US Sales Office. This technical support includes assistance with RidleyWorks[®] Design Software, as well as design applications in testing and measurement. This contact information is listed below.

Purchasing an AP310: If your company would like to purchase a new AP310, 35% of rental amounts paid are applicable toward the purchase price. You may request a formal calculation of the buyout price at any point during the rental period. The rental unit is not for sale.

Returning the AP300 Rental: The AP300 Analyzer System is shipped to your company via 2nd day air using your FedEx or UPS account as noted on the following page. At the end of the rental period on the anniversary date, return the Analyzer System via 2nd day air to the address below, in the same condition in which it was received:
